

# Position: Consultant – Trainer and translator, Labor Standards (French)

## Job Description

In 2024, SAI is undertaking a full revision of our <u>SA8000 Standard for Decent Work</u>. The SA8000 Standard is the basis for all of SAI's programs to advance human rights for workers around the world, from our flagship <u>SA8000 Certification Program</u> to our <u>capacity building work with brands, companies and other organizations</u>, to our <u>systems-focused landscape projects</u>. It is also used as a benchmark by many other standards, policymakers, and in company codes of conduct.

The purpose of this revision is to ensure that the SA8000 Standard continues to serve as a leading benchmark for ethical workplaces at all levels of the value chain, reflecting evolving human rights risks and good practices.

To achieve this, we are seeking a trainer and translator (English and French), with experience working professionally on issues related to SAI's work (e.g., labor rights, social auditing programs, voluntary standards and certification systems, human rights due diligence, management systems for social performance, etc.) to support delivery and simultaneous translation of multiple online webinars in September 2024. There is potential for the consultant to be contracted for future training and/or translation work with SAI.

#### The consultant will:

- Work with SAI's internal SA8000 Revision Committee to understand key messaging about the Standard revision and public feedback period.
- Deliver two online webinars (1.5 hours each) in French about the Standard revision process and feedback period.
  - Alternatively, the consultant could provide simultaneous translation from English to French for these webinars.



 Support translation of audience questions and SAI technical team's responses during and following webinars.
